#### **Report from Lambec**

The 2018 summer programs were successful! Camp Lambec retained many campers from previous years and added new ones. We're truly grateful for the many volunteers that support the fruitful ministry at Lambec through their prayers, financial contributions, sacrifice leading and directing CAPNWP programs, participation in work days, etc. A HEARTY THANK YOU TO ALL!!

The new water system is working as designed by our engineering firm. The meter readings are showing numbers within the new parameters set by the Pennsylvania Department of Environmental Protection and Erie County Health Department. The last piece of equipment that will increase the chlorine to water contact time is being installed and the automated reporting system and data recording device is nearly finished. The DEP will inspect the water system within the next several weeks.

#### **Report from Westminster Highlands**

It remains the intention of the Board to sell Westminster Highlands. Members of the Board met with representatives from American Appraisers. They will complete an appraisal of all of the properties belonging to Westminster Highlands. An attorney is helping to resolve matters associated with one of the WH parcels. This title work is expected to be completed in several months.

#### **Report on Administration**

Presbyterian Media Missions is continuing to handle our marketing programs. Randall will talk with Gregg Hartung about the marketing for 2019. The program of the summer camp programming will be approved at our October meeting so that Presbyterian Media Mission can create the summer brochure before the end of this year.

Randall is working on revising job descriptions, policies, and procedures for the summer staff. A draft Operations Manual will be presented to the Board for consideration and approval in early 2019.

Our Financial Consultant, Mary Ellen Oros, is working on the 2019 budget. It will be submitted for Board approval in October.

Randall and Gary are meeting with staff members of the Pine Springs Camp (Redstone Presbytery) and Camp Crestfield (Pittsburgh Presbytery) to explore how we can work together by sharing resources, personnel, program, etc.
